The Reason We Exist:

Comptrollers Report Concludes Discrimination

Economic Cornerstone has, as its mission, taken on developers that dodge minority hiring requirements for good reason. A report compiled by the NYS Comptroller, Thomas P. DiNapoli's office, supports what we've all known, yet few do anything about. This report was compiled after the completion of New York States Disparity Study completed July 2010.



Although 29 percent of firms were identified as MWBEs in the disparity study, only 5 percent of New York's contracting and purchasing dollars were spent with MWBE firms from State fiscal years 2004 through 2008. The study concluded that the statistical and anecdotal evidence supports the conclusion that these outcomes are the result of discrimination.

Agency performance data over the last three years show that utilization of MWBE firms continues to be relatively stagnant. The combined percentage of MWBE utilization increased only 1.5 percentage points from 8.1 percent of agency expenditures in State fiscal year 2007-08 to 9.6 percent in 2009-10. Gov. Andrew M. Cuomo has set a new state goal to award 30 percent of government contracts to MWBEs. We have a long way to go to catch up.

NYS Increases MWBE participation to 30%

Gov. Andrew M. Cuomo has set a new state goal to award 30 percent of government contracts to minority and women-owned business enterprises, while recently also signing legislation meant to boost their participation. He disclosed that the state's MWBE utilization reached 25 percent of contracts, a total of nearly \$2 billion, surpassing the original 20 percent commitment he made in 2011.

As Newsday reported, the state "continues to be a leader and pioneer in MWBE utilization in the nation," said Phil Andrews, president of the Long Island African American Chamber of Commerce, which is working toward increasing the number of certified MWBEs in its member network.

The new law and goal means business owners will be taking a chance and hiring more people.
